In partial modification of this directorate notice of even number dated 5th August, 2020 and in pursuance of Govt. of Manipur, Sect: Health Department letter No. 2/7/2019-M(Pt.) dated 7th August, 2020, eligible & intending candidates are invited to the Walk-in-Interview for contractual engagement of Medical Officers under this Directorate for a period of three months for utilisation in COVID related duties.

Details of the post.	Essential Qualifications required for Medical Officer post.
Name of the post : Medical Officer. Number of post = 100 (one hundred). Remuneration = ₹ 2500/- per duty day as per Finance Department (PIC), Govt. of Manipur U.O. No. 76 / 2020 – 2021 / FD (PIC) dated 30 th July, 2020.	i) Possession of a recognized Medical qualification included in the First or Second Schedule, or Part-II of the Third Schedule (other than licentiate qualification) to the Indian Medical Council(IMC) Act, 1956. Holders of educational qualifications included in Part-II of the Third Schedule should fulfill the conditions as stipulated in Section 3(3) of the IMC Act, 1956. ii) Completion of compulsory rotating internship. iii) Possession of Registration Certificate issued by MCI/ State Medical Councils. <i>Note: Candidates should possess all required essential qualifications on the last date of walk-in-interview.</i>

2. Upper age limits : 38 years (unreserved), 41 years (OBC) and 43 years (SC/ST) and 48 years (PWD- Persons with disability). *Qualifying date will be as on the last date of walk-in-interview.*

3. Reservations will be as per State Govt. norms/ policy.

4. Application Forms may be obtained from Directorate of Health Services, Manipur, Lamphelpat on cash payment of ₹ 1000/- (₹ 700/- for SC, ST and PWD). Application forms may also be downloaded from the website of this directorate. Print-out of the application form (in Legal size bond papers) may be filled up and submitted to the Directorate of Health Services, Lamphelpat along with cash payment of ₹ 1000/- (₹ 700/- only for SC, ST and PWD) on the day of interview.

5. Due to exigency of doctors for fighting the COVID pandemic in the State, the important datelines have been shortened/ reviewed as follows :

Issue of Application Forms : 8th - 11th August, 2020.

(from 11 AM till 4 PM daily including Sundays & holidays in Directorate of Health Services, Manipur).

Date of Walk-in-Interview : 12th & 13th August, 2020 (8 AM onwards daily on a first come, first served basis); dateline may likely extend according to the number of applicants/candidates.

Place of Walk-in-Interview : Directorate of Health Services, Manipur, Lamphelpat.

Eligible candidates shall submit the duly filled in application forms along with the required essential documents (both original and self-attested photocopies) to this directorate at the time of attending the walk-in-interview, failing which, the candidate will NOT be allowed to appear in the interview.
